Public building law forms the basis for successful real estate development. It determines how a property may be built on and used. When applying public building law, developers and public decision-makers are confronted with a multitude of complex regulations in a multi-level regulatory structure that offers considerable leeway in favor of convincing development concepts. In 2023, the real estate industry will face challenges. After the ushering in of the Building Land not only in economic terms, but also in legal terms. After the Building Land Mobilization Act began, the focus is now on ESG requirements, an amended Renewable Energies Act and a new funding framework for new construction and refurbishment.

In addition, there is the digitization of planning and approval processes. According to the Online Access Act, one should be able to apply for building permits online everywhere from 2023. However, this goal has been missed in many places, as has the accelerated issuance of building permits.

Despite the tight market situation, those who seize their opportunity can benefit from robust trends - for example, in logistics, serviced apartments, and the refurbishment of office space - and take advantage of the simplification provided by the Building Land Mobilization Act, especially for residential construction.


