Joel's practice has involved a wide range of issues, including Office for Civil Rights (OCR) and Department of Justice (DOJ) civil rights investigations, research misconduct investigations, faculty and staff labor and employment issues, adjunct and full-time faculty unionization efforts, donor disputes and restricted gift compliance, Title IV compliance, federal and state privacy law compliance, and governance.

Joel has represented institutions and associations in federal and state courts at trial and appellate levels, and in litigation before federal agencies. He has helped a number of institutions in accreditation matters before regional, national, and specialized accreditors, including commenting on proposed standards, requesting substantive changes, and responding to sanctions.
