## **Confirmed Speakers**



**Dr. Oliver M. Brupbacher**, Senior Corporate Counsel, Global Litigation at Novartis, Basel. Oliver manages group material litigations, arbitrations and investigations for Novartis and founded the Discovery Center of Excellence at the group's headquarters. He currently also acts as the ex-US business lawyer to Novartis' Ophthalmology Franchise. Prior to Novartis, he was an Attorney-at-Law at Bär & Karrer, Zurich. Oliver is a Swiss qualified lawyer and is admitted to the Zurich bar. He holds a Doctorate of Law from the University of Zurich and a Master of Laws from the University of Cambridge, England. Oliver's experience includes in particular healthcare law, complex cross-border dispute resolution and transactions, data privacy, secrecy and transfer restrictions as well as information governance at the intersection of litigation, data and digital.



**Ulrike Fürst**, Presiding Judge, Commercial Chamber, Court Mediator and Press Officer, Regional Court, Munich. Ulrike has worked within the Bavarian judiciary for nearly 30 years, at the outset as a prosecutor including two years at the Attorney General's Office of the Free State of Saxony (international mutual legal assistance and GDR injustice). For ten years, she was a lecturer at the Bavarian College of Public Administration. Additionally, Ulrike is a coach for negotiation management and business mediation and coaches Bavarian trainee lawyers. She also has trained court mediators in North Rhine-Westphalia and is due to join the team for the training of court mediators of the Bavarian judiciary.



**Dr. Beata Gessel-Kalinowska vel Kalisz**, Senior Partner at GESSEL, Warsaw. Beata is an expert practitioner in arbitration, M&A, private equity and commercial law. She is a renowned arbitrator, a member of the ICC International Arbitration Court and an adjunct professor at the Cardinal Stefan Wyszynski University. In 2015 – 2018, as a visiting academic at Oxford University, Cambridge and Wolfson College, she run comparative law research on M&A. Her recent book "Legal, Real and Converged Interest in Declaratory Relief" published by Kluwer Law International, focuses on declaratory relief in litigation and arbitration.
