

# The Digital Services Act Package

The EU Commission has published its long-awaited draft proposals for the Digital Services Act (DSA) and Digital Markets Act (DMA). The DSA, alongside the DMA, is part of the EU Commission's digital strategy aiming to reinforce the single market for digital services and to create a more level playing field for digital businesses of all sizes across the EU.

## Spotlight on the Digital Services Act (DSA)

The draft DSA aims to update the E-Commerce Directive and sets out new and revised rules regarding the responsibility of online platforms (social networks, search engines, online marketplaces etc.) for risks to users, such as illegal goods, illegal content and misinformation.

Among other things, the draft proposals include:

- A detailed set of rules on tackling illegal third party content through a harmonized Notice and Action mechanism
- A new regulatory framework for targeted advertising
- Additional obligations for large platforms that have more than 45 million monthly active users in the EU
- Severe penalties for digital service providers who fail to comply with the new regulations

# Spotlight on the Digital Markets Act (DMA)

The draft proposals impose a series of ex ante behavioural rules for digital platforms designated by the European Commission as 'gatekeepers' in the context of one or more 'core platform services'. It builds on the existing <u>P2B Regulation</u>.

Among other things, the draft proposals include:

- · Constraints on data accumulation
- A ban on the tying of software applications
- Restrictions on 'gatekeepers' treating their own offerings more favourably

The Commission's enforcement action is expected to be intense, with ten on-site investigations per year and an additional 80 full time staff.

#### **Impact**

The legislation will draw significant interest from a wide range of players, given the scope of services affected and the fact the rules are intended to cover all digital services, whether or not based in the EU.
